Module 1: Two State Assemblies

Who knew?

Our American Government has TWO State Assemblies.

- An International State Assembly for each of the States of the Union.
- A National Union State Assembly for the collective counties of each "state" called The Union State.

What is the International State Assembly?

- There is one for each State of the Union making that a total of 50 International State Assemblies.
- They oversee the Land, Sea and Air jurisdictions.
- They are run by publicly-elected officials, the American State Citizens, and by appointed or non-publicly elected American State Nationals.
- Its governing structure is comprised of Four Assembly
 Pillars called the General Assembly, the Jural Assembly,
 the International Business Assembly and the Militia
 Assembly.

Steps to forming the International State Assembly

- First, you bring your State into General Assembly.
- Second, you develop your Jural Assembly, Militia, and International Business Assembly and elect your officers and establish your jury pools and your treasury.
- Third, after your Assembly is fully functional and seated, you turn your attention to funding and providing services for the people of your State by establishing a State-of-State Constitution and hiring people and/or organizations to provide the routine day-to-day services of State Government.
- Fourth, you establish your Annual Calendar for the actual State Assembly to meet and conduct business, and identify any large statewide or international issues that your members will need to work on as Committeemen/women in the interim between Sessions and make recommendations during the next regular Refer to this article as a reference: https://annavonreitz.com/wyomingassembly.pdf.

Please Note the Seal of an International State of the Union Assembly

A State of the **Union Assembly** seal has no county lines for this jurisdiction governs the entire State unit as a whole with superior, concurrent, general jurisdiction governing the

How is the Union State Assembly different?

Not much is known yet about the Union State Assembly, but what is known is that:

- The many counties within the borders of each State make up their Union States.
- Each Union State creates its own Union State Assembly.
- These Union State Assemblies oversee the national soil jurisdiction.
- These Union States do business as The United States.
- These Union States delegated some of their powers to the States of the Union for their own protection against foreign interference in the international jurisdictions of the land, sea and air.

Please Note the Seal of a National Union State Assembly

A Union State Assembly seal has the county lines drawn for delineation to indicate the national soil jurisdiction which it governs.

Module 2: Seatment

As we are learning more about the soil jurisdiction, our focus is now on the **Seatment** of the International State Assembly.

Remember Step 3 said: "Third, after your Assembly is fully functional and seated,"

How do we Seat an Assembly?

So, let's back up.

- First question: What does each of the Four Pillars need in order to bring our government into full function?
 - The answer: People.
- How do you get people?
 - The answer: Outreach AND Recruitment.
- Government is business and it needs not just "people," but competent people to make it functional, so your outreach must have "recruitment" as its focus when it comes to

How does a business recruit?

- They go to events where the talent is or create events where the talent will come to you.
- Think about it this way: If you want to recruit a basketball player, you would not go to a hair braiding show to find one.
- Translation: To find competent people to run our government, attend the "likely" events where you will find them or create the "likely" event where they will come to you.
- A targeted and effective outreach and recruitment system to find competent people is the

The members of the 3 Service pillars – the Jural Assembly, International Business Assembly and Militia Assembly - comes from the 1 main body, the General Assembly. If your outreach and recruitment system is running smoothly, consistently and effectively, you will always have a pool of competent people within your General Assembly to fill the offices within your service pillars to keep them functioning properly.

Next, make your Four Pillars functional

- The General Assembly handles in-state business composed of State Nationals and State Citizens.
- The International Business Assembly handles out-of-state business composed of State Citizens.
- The Jural Assembly handles court services and law issues.
- The Militia Assembly handles militia services involving state-level deployment of assistance to local counties and participating in interstate rescue, relief efforts, public

Here is the Blueprint

- Organize each of the 4 pillars to perform their functions as described in the previous slide,
- Elect public officials,
- Establish a jury pool to even include Americans who are employed as federal citizens, and
- Establish a treasury to include a bank account for managing your State budgets and expenditures and State Trust funds.
 - These priority goals will get your State Assembly to Seatment. More on how-to later.

After Seatment

"Third, after your Assembly is fully functional and seated, you turn your attention to funding and **providing services** for the people of your State by establishing a State-of-State Constitution and hiring people and/or organizations to provide the routine day-to-day services of State Government"

- This means that your Service pillars Jural Assembly, International Business Assembly and Militia Assembly – will need constitutions in order to provide their services to the American people.
- Constitutions are drafted after Seatment.

What services will your State Assembly provide?

Remember the fourth step in forming this Assembly that was mentioned before which states:

"...identify any large statewide or international issues that your members will need to work on..."

Who? Members of your Jural Assembly, International Business Assembly and Militia Assembly.

Let me point out...

How does the International State Assembly assist the National who is experiencing things like...

- House being seized for not paying property taxes or mortgages you didn't owe.
- Child being kidnapped by Children and Family services for not having a vaccine.
- Car being stolen on impound for driving without a license.

Know what the International State Assembly handles

- "...large statewide and international issues."
- These are crimes you need addressed when they are taking place in the moment that they are happening and who do you go to for that?

Your County Assembly Government in our Supreme Courts, and more appropriately, your American Town government which is still "missing in action."

Once you report the crime to your **Soul Jurisdiction County Sheriff**, he can then perform his investigation and will for sure find that the **Corporations** are involved in *mail fraud*, *human trafficking*, *peonage*, *and* racketeering due to the creation of estate trusts and the federal reserve notes' credit-theft monopoly.

Then, he has the duty to pass on this evidence to your Land Jurisdiction Peacekeeper for the State Assembly, the Continental Marshal.

Your International State Assembly has the responsibility to investigate and try these matters in their Jural Assembly State Courts and liquidate these unlawful corporations who have for 160-years infringed on the jurisdiction of the living people.

Module 3: Functional

The Blueprint

How to make a General Assembly functional?

- Publish an annual Calendar of public meetings for public view.
- Hear reports of Sub-Committees.
- Hold elections.
- Bring the Assembly in and out of session.
- Vote on the expenditures of all Four Pillars.
- Provide Ombudsman service to resolve conflict among Committeepersons to facilitate the timely handling of government business.

- Perform Oversight of the conduct of Assembly officers and Committee practices and proceedings to hold them accountable for their conduct and decisions.
- Provide an open forum where the American people can address their government with their matters of concern.
- Keep 5 Standing Committees in session all year round when General Assembly goes out of session – Ombudsman, Oversight, Sessions, Treasury and Public Safety Committees.
- How many Assemblypersons are needed to fill the Committees of this pillar? 7 for publicly-elected offices (Chairperson, Vice-Chairperson, Records Keeper, Ombudsman, Secretary, Treasurer, Recorder) and a minimum of 3 per 13 Committees totaling 39, (although many of these Committees are optional.)

How to make an International Business Assembly functional?

- The International Business Assembly drafts up service provider agreements, general contracts, constitutions, or debt agreements – all the same thing but of a different flavor.
- For what statewide services are providers needed? Militia services, Jural services, and International Business services.
- Develop an effective process for gathering the input from your County Assemblies to identify and compile the priority, international service needs there are for your State.
- Gather international and global intelligence to inform the

- Qualify the type of service providers your State will contract with, develop a strategy for locating these qualified service providers and catalog them in a database according to service areas, location, and jurisdiction.
- Draft up lawful (land) and legal (sea and air) contract templates that could be executed appropriately given the type of service and jurisdiction of the service provider.
- How many Assemblypersons are needed to fill the Committees of this pillar? 0 publicly-elected offices and a minimum of 3 per 3 Committees totaling 9.

The Elephant in the room...

- Is your Territorial State-of-State subcontractors under a contract with your International State Assembly or not to provide you with any government services?
- According to the third step to forming a State
 Assembly, "establishing a State-of-State
 Constitution and hiring people and/or
 organizations to provide the routine day-to-day
 services of State Government," comes after
 seatment.
- How do our State Assembly's handle their

- We address this matter to the foreign, federal Employees with whom we have a contract, the U.S. Military, and tell them to release our Trust funds and our government property (to include the buildings which are not theirs), so we can get on with the business of hiring our own government services providers. Thank you very much.
- The Territorial States-of-States are fully aware that where there is no contract, there is no duty to perform anything that we want to demand of them. Are we aware? Do you have a Constitution with the Territorial States-of-States? No. Their Constitutions are with the U.S. Military.
- When they act where there is no contract, we let them know.
- We need our International State Assemblies to be scouting out for us qualified and accountable government。

Did you know?

- Did you know that our Fiduciary hired Trump as Commander-in-Chief, for better or for worse?

Are you ready?

Are you ready to call a meeting with our Employees yet, Trump and the U.S. Military, to talk about his contractual obligations and negotiate the "Transference of Governance" back into our rightful hands in one-fell-swoop?

Now moving on...

How to make a Jural Assembly functional?

- What types of cases are tried in the international jurisdiction? Land (Lawful Person) and Sea (Legal Person) and Air (LEGAL MUNICIPAL PERSON) cases
- Where will these cases be tried?
 In the County where you locate your State Court
- To establish a jury pool, develop a cost-effective data collection process to gather the names and contact information for potential jurors in your State per County.

- Identify Americans who are employed as federal citizens in your jury pool.
- Account for Talesmen in your jury pool process.
- Draft court processes for trying land jurisdiction cases in your State Courts and processes for trying sea and air jurisdiction cases in your Postal District Courts and finetune the execution of these processes through holding mock trials.
- How many Assemblypersons are needed to fill the Committees of this pillar? 4 for publicly elected offices (Coroner, Clerk, Bondsman, Justice) and a minimum of 3 per 8 Committees totaling 24.

How to make a Militia Assembly functional?

- Similar to the system of the Swiss Cantons, their focus is community safety and preparedness on a statewide basis.
- Members are taught firearms safety, marksmanship, first aid, and train in one or more specialties.
- In the event of attack or natural disaster, the State Militia Commanders can call upon one or more County Community Resiliency Units (militias) for assistance.
- They can also call upon the "State of State" Militias, the State of State "National Guard" and the local U.S. Military Commanders for assistance.

- Establishes and maintains a State Border
 Defense plan with all the Counties along their borders.
- Reports to the 1 standing Committee that remains in session all year round when General Assembly goes out of session - the Public Safety Committee.
- How many Assemblypersons are needed to fill the Committees of this pillar? 1 for publicly elected office (Militia Commander) and a minimum of 3 per 4 Committees totaling 12.

Here's the reality

- 4 Pillars, 11 publicly elected officials, and roughly 87
 Assemblypersons, if you choose to fill all the
 Committees as suggested.
- Yes, I meant to say "persons" deliberately –
 Committeepersons, Chairpersons, Assemblypersons.
 There are no men or women in the International Land,
 Sea and Air jurisdictions. They are Lawful Persons,
 Legal Persons and LEGAL PERSONS.
- How long do you think it should take an International State Assembly to become fully functional and seated?

Module 4: Roadblocks to Seatment

Let's Observe

- The State Assemblies were called into session on June 19, 2017.
- The last Territorial State was enrolled as an official State of the Union on October 1, 2020.
- The date of this writing is September 28, 2025.
- How many State Assemblies are seated today?

Zero.

Why is that?

I can give you four reasons that I have observed:

- 1. Lack of competent leadership in Coordinators and in elected Assembly officers.
- 2. Lack of qualified and effective Ombudsman service that can quickly resolve the conflict that hinders Assembly progress.
- 3. Lack of professional, non-biased Oversight of the conduct of our elected Officers and of our Committees practices and written procedures to hold our government officials accountable.
- 4. Lack of respect and working knowledge of jurisdictions being observed where the International State Assemblies take their direction from the National Soil County Assemblies to protect the men and women and their assets from the foreign, corporate government infringement.

Let's remedy all of that and get seated.

Module 5: How to Seat an Assembly

A Pathway to Seatment

- Start with adopting an outreach and recruitment system to generate a constant flow of potential members to fill your General Assembly with competent People.
- ✓ For standing your **General Assembly**,
 - First, fill your standing Committees that never go out of session even when you do the Ombudsman, Oversight, Treasury, Public Safety and Sessions Committees develop them to full function.
 - Then, add on the other Committees

- ✓ For standing your International Business Assembly,
 - Build a network between your County Assemblies to ascertain what their collective, priority service needs are.
 - Reach out to **potential service providers** that meet your criteria to be considered as a viable subcontractor.
 - Build a database of them to be positioned to hire when you have secured your funding.
 - Then design templated constitutions or service agreements based on those needed services and the jurisdictions of your potential service providers, land or sea.

- For standing your Jural Assembly,
 - As you outreach and bring people home, inform them of their duty to serve as a juror upon intake.
 - Log them securely and efficiently in your database of jurors categorized by County, by age, and by employment, so you can easily identify potential conflicts of interest and eligibility.
 - Then bring your international land, sea and air jurisdiction courts into full function by designing your process for jury selection and trial procedures for land cases versus sea cases. (Please note, there are no "people" in the land, sea and air they are "People" and "Persons/PERSONS.")

- ✓ For standing your Militia Assembly,
 - As you outreach and bring people home, inform them of their duty to serve in the militia upon intake.
 - Build a member database categorized by County, skillsets, age, Peacekeeping Office as well as de facto Law Enforcement Offices.
 - Report to the one committee that never goes out of session even when you do the Public Safety Committee.
 - Specifically, build a functioning network of border County Assemblies who can execute your **State Border Defense** plan of action in preparation of an attack or a disaster.

After your Pillars are functional, what's left?

If you haven't already,

- ✓ Hold your public elections to elect your 11 officers.
- Establish your treasury with some National Credit Union, if GFG is not operational yet.
- ✓ Post your Annual Public Meeting schedule.

Please Observe

"Seatment" is administrative only – meaning – your International State Assembly has its organizational structure in place and implementation handbooks written down on paper and ready to execute once the funding is secured to hire the employees to provide your government's day-to-day operations. In this respect, "fully functional" is essentially limited in fact, because you don't do the work, you administer it.
