### HISTORY

*When the government agency "U.S. Post Office" was "Privatized" in 1971, the government "Executive Branch Agency" ceased to exist, and the duties and obligations thereof were taken over by the "U.S. Postal Service, Inc." a private, for-profit corporation.*

### LAWFUL VS LEGAL

*When the private, for-profit corporation took-over the previous "government agency," it inherited the "assets" and "liabilities" of the former Constitutionally created "U.S. Post Office." The laws that govern postage may never and cannot ever be rescinded, repealed or amended.*

*Refer to: First Class, Non Domestic Without Prejudice (USC-1-207) bk 12 Statutes at Large Chapter 71 Section 23, 37<sup>th</sup> Congress Session 111*

*One of the "Liabilities" that it inherited, – is the obligation to continue to deliver "Non-Domestic" mail at the "Drop Letter" rate of 2 cents per 1/2 ounce, or 4 cents per ounce "non-domestic rate" established by "Law". (Not the present "Code" or "DOMESTIC MAIL Regulations"). Cards cost 3-cents per half-ounce. For manila envelopes use 3-cents per half ounce.*

*Also note that "Drop Letter" means you must "drop" the mail in a home mailbox or in the box OUTSIDE the post office. DO NOT HAND NON-DOMESTIC mail for "outside the US" to the mailman or clerk at the US window for employees inside.*

### FOR-PROFIT CORPORATION OR ABOLISHMENT OF FREE LOCAL GOVERNMENT

*The Posts are pushing their employees to continue "making money" for their privatized service by treating ALL mail as "DOMESTIC" Mail.*

*This lack of education and training given to new Postal employees appears on the outside to be purely profit-oriented. It also serves to make postal employees unaware of the fact that the US Posts were created by the laws of the free unincorporated American Constitution to serve free American men and women living in the fifty unincorporated states (including they themselves: postal workers who are free American men and women when they are not at work).*

*Do postal employees realize what they are actually doing?*

*Some POSTal employees are refusing to handle "Non-Domestic" mail (dropped in the box outside the Post Office) the correct way and are returning mail or sending it with "postage due".*

*This is **abolishing local government and removing their own free rights** to be treated as free Americans when they are not at work.*

*These employees probably do not know the difference between free unincorporated states like "California" abbreviated as "Calif" and incorporated States like "State of California", "STATE OF CALIFORNIA" or "CA".*

## **By POST-AL COURTS**

*The Post Office is a "COURT OF RECORD".*

**USE STAMPS ONLY!!!**

**Never let them PRINT A STICKER WITH POSTAGE PRINTED ON THE STICKER!!**

*They probably are also unaware that "Post Offices" were designated as "Posts" for "common law courts" and mailing for legal purposes is still in use today (ex service of documents between corporate entities – bills addressed to you in your "ALL CAPS NAME".. Posts also designate "jurisdiction". Changes in jurisdiction (as in the Post Office refusing to acknowledge Non-Domestic mail) can take away the jurisdictional rights of Americans, including those of postal workers when they are off work.*

## **DOMESTIC VS NON-DOMESTIC**

*Mail matter sent between, among, to or from any "government Agency or Wholly-owned government Corporation," – is "**within**" the corporate government, and is "DOMESTIC U.S. MAIL."*

*Domestic means within government, THEIR incorporated territory – Washington DC, any military base, any federal zone indicated by using state abbreviations and zip codes.*

*Mail matter sent **outside of government** - between, and among, to and from "private" (real living) "people" (whose names are spelled using "Upper-Lower-Case Letters") is "Post Drop Letters" and NOT U.S. corporate (government) mail and is "Non-Domestic."*

Non-Domestic Mail moves outside of D.C. its possessions and territories, which means "outside of the United States" which means it is mail going to and from a living man or woman in any of the fifty states:

## **HOW TO" NON-DOMESTIC**

**\*Mail is To and From your-unincorporated-home-state (state spelled out completely with no abbreviations)**

**\*"Non Domestic, Without the US" must be inscribed on both labels.**

**\*Note: 3 cents Mail is drop-letter mail to general Post**

## **Two-cent postage instructions:**

The law requires that (all) ½ ounce letters be delivered anywhere in the Continental US for two cents, meaning to any of the unincorporated American States with geographical boundaries.

\*Two cents per half ounce applies to personal mail between individuals.

\*Two-cent postage instructions for two-cent mailings:

Do not use zip codes.

Do not abbreviate any states.

## **AN EXPLANATION OF ZIP CODES**

The free unincorporated American state, using as example California, with living people in it, is abbreviated as "Calif". Zip codes are not used when living people send mail to each other.

The U.S. Postal Service cannot discriminate against the non-use of ZIP codes, pursuant to the Postal Reorganization Act Section 403 (Public Law 91-375).

Non-Domestic mail does not use zip codes. Zip codes can be completely omitted or enclosed with Brackets - [12345] – to show deletion of what is inside.

The use of zip codes is informing the Post Office that you live in Washington DC and are living temporarily at your residence address to do business.

## **Zip codes indicate Federal Regionalism (the abolishment of local government) :**

**Zip Codes** are required when using "federal regions"

such as CA, NV, AZ, etc.

abbreviated indicate:

Must now use "jurisdictional regions or zones"

such as "CA", "NV", "AZ", etc.

that are not abbreviations of the actual geographical American state, but are "two-digit designations" of the incorporated federal US fictional overlays (counterfeits created by using corporate statutes and Codes); "States of States" (State of Texas or STATE OF TEXAS) with **NO** geographical boundaries).

Free states of free, living Americans have designated geographical boundaries created by our founding fathers.

US Corporate entities like our current privatized post office, have created fictional States of States (State of Virginia) that have no geographical boundaries.

The U. S. Postal Service cannot discriminate against the non-use of ZIP codes, pursuant to the Postal Reorganization Act, Section 403, (Public Law 91-375).
